ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is Dwight Yates Janitorial & Cleaning Service, Inc., and its principal place of business shall be located at 711 Forrest Avenue, Unit 1, Cocoa, Florida 32922.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.
