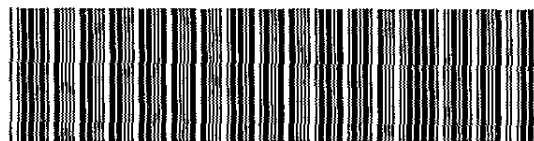



**ARTICLE VII. BOARD OF DIRECTORS**




**ARTICLE IX. AMENDMENT**
