

AMENDMENT



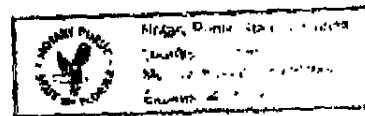


