ARTICLES OF INCORPORATION

ARTICLE I: The name of the corporation is: Universal Construction Services of Florida, Inc.

ARTICLE II: The principle place of business of the corporation is: 1250 Wiley Street,
Hollywood, Florida 33019-2249.

ARTICLE III: The purpose(s) for which the corporation is organized is: To engage in
construction clearing services and all such other permissible purposes under the Florida
Business Corporation Act (Chapter 607, as amended).

ARTICLE IV: The number or shares of stock that the corporation is authorized to issue is: 100,000 shares Common stock, no par value per share.

- (a) the amount of a financial benefit received by a director or officer to which s/he is not entitled;

- (c) a violation of FLS 607.0850(7)(a)(b)(c) or (d) (or its successor); or
- (d) an intentional violation of criminal law.

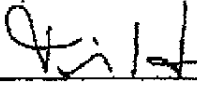
