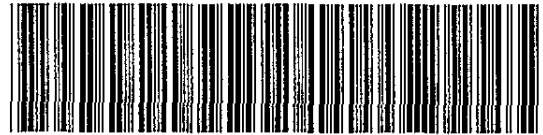
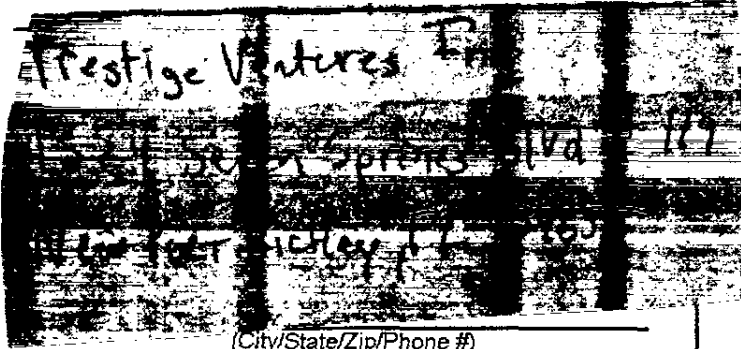

ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE II - NATURE OF BUSINESS

ARTICLE IV - CAPITAL STOCK


