ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE Name

The name of the corporation is: INTERCOASTAL MARINE CONSTRUCTION SERVICES, INC.

ARTICLE TWO Principal Office

The duration of the corporation is perpetual.


ARTICLE FOUR Purpose or Purposes
