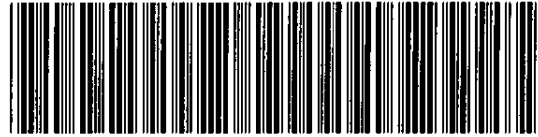




SUNCOAST SPARKLE BRITE, INC.


