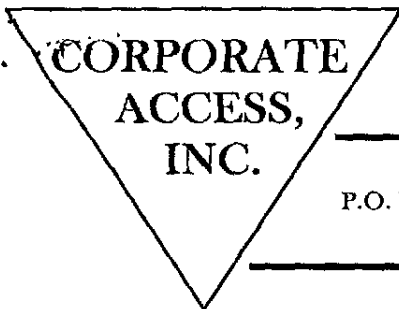

## ARTICLES OF INCORPORATION

We, the undersigned, subscribers to the Articles of Incorporation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

### ARTICLE I

The name of the corporation shall be /RUSTY CONSTRUCTION, INC. Its principal place of business shall be 2383 Orangeside Road, Palm Harbor, Florida 34683. All correspondence shall be sent to 2383 Orangeside Road, Palm Harbor, Florida 34683.

### ARTICLE II
