ARTICLES OF INCORPORATION OF SECRETARY OF STATE WELL-RUN CONCEPTS, INC.

- 1. Name. The name of the corporation is: WELL-RUN CONCEPTS, INC.
- 2. Purpose. The corporation may engage in any legal business.
