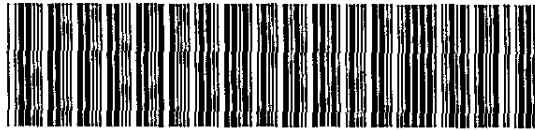



**Name**


