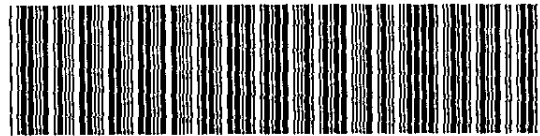

**ARTICLES OF INCORPORATION  
FOR  
JJ Beauty Supply, Inc.**

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE ONE – NAME**

The name of the corporation shall be **JJ Beauty Supply, Inc.** This corporation shall be constituted and shall operate as a Florida Corporation for profit, the existence of which shall commence upon the filing of these Articles of Incorporation.

**ARTICLE TWO – PRINCIPAL PLACE OF BUSINESS**

The principal place of business and the mailing address of this corporation shall be 13217 Northwest 7<sup>th</sup> Avenue, North Miami, Florida 33168.

**ARTICLE THREE – CAPITAL STOCK**

The maximum number of shares this Corporation is authorized to issue is 100 shares, with a par value of \$10.00 per share, all of which shall be Common Shares.
