ARTICLES OF INCORPORATION

We, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

ARTICLE I

THE NAME of the Corporation shall be:

THE CORPORATION may engage in any activity REALTOR ASSOCIATES, permitted under the laws of the United States of America and of the State of Florida.
