

## ARTICLES OF INCORPORATION

## DOWNTOWN YOGA, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: DOWNTOWN YOGA, INC. The principal office of the Corporation is 532 New Haven Avenue, Melbourne, Florida 32901. The mailing address of the Corporation is 20 N. Orange Avenue, Suite 600, Orlando, Florida 32801.
  - Article 2. Duration. The duration of the Corporation is perpetual.
- Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
