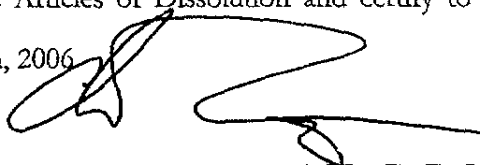

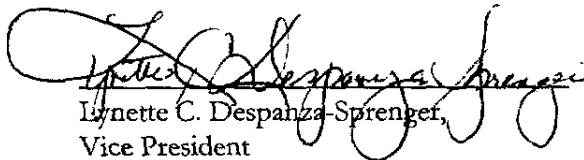
##### Method of Dissolution
