The undersigned incorporator does hereby make, subscribe, file and acknowledge these Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act and the Florida Professional Service Corporation Act.

ARTICLE I NAME OF CORPORATION

The name of the corporation is FEINGOLD SCHECHTER P.A. (hereinafter, the "Corporation").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS
