ARTICLES OF INCORPORATION OF CHEN PODIATRIST, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME.

The name of the comporation shall be: Chen Podiatrist, Inc.

ARTICLE IL ADDRESSES.
