ARTICLES OF INCORPORATION OF KAI'S RESTAURANT, INC.

SECRETARY OF STATE

The undersigned, acting as Incorporators of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation shall be KAI'S RESTAURANT, INC.

ARTICLE II-PRINCIPAL OFFICE
