ARTICLE I, NAME OF CORPORATION:

The name of the Corporation shall be:

The general nature of the business and the object and purposes to be transacted and carried on are.

To conduct any and all business not prohibited by the Laws of the United States and State of Florida.

The initial place of business of said Corporation in this State shall be **2360 OAK COURT, PEMBROKE PINES, FL. 33026.**




