## ARTICLES OF INCORPORATION OF H. BANKS ROBINSON, INC.

The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract hereby forms a corporation under the laws of the State of Florida, effective February 5, 2006.

## ARTICLE I

The name of this corporation is H. Banks Robinson, Inc.

#### **ARTICLE II**

The general nature of this business to be transacted by this corporation is real estate investing and related services.

- To engage in any activity or business permitted under the laws of the United States and of this state.
- To the same extent as a natural person might or could do, to purchase or otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or otherwise dispose of and deal in, lands and leaseholds, and any interest, estate, and rights in real property, and any personal or mixed property, and any franchises, rights, licenses or privileges necessary convenient, or appropriate for any of the purposes herein expressed.
- 3. - 5. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, or other evidences of indebtedness, and to execute such mortgages, transfers of corporate indebtedness as required.
