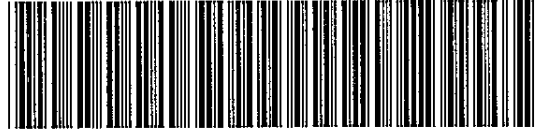

**ARTICLES OF INCORPORATION
OF
You Just Believe, Inc.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: You Just Believe, Inc., and the purpose for which the corporation is organized to conduct any and all lawful services in the State of Florida.

ARTICLE II

The street address of the principal office of the Corporation is: 722 Sailfish Drive, Fort Walton Beach, Florida 32548.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 500, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
