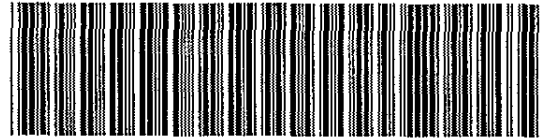

**Article I. Corporate Name**
