The undersigned hereby makes, subscribes and organize and incorporate a business for profit under the laws of the State of Florida Statues, Chapter 607.

ARTICLE I – NAME



- C.) Unless otherwise provided in the By-laws, cumulative voting shall not be permitted.



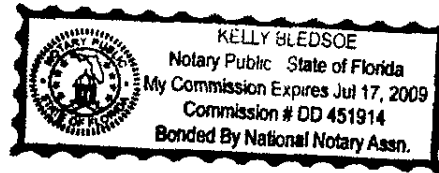
