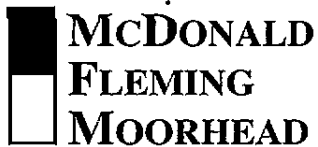

**ARTICLES OF INCORPORATION
OF
ELECTRICAL SERVICES OF PENSACOLA, INC.**

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this corporation is ELECTRICAL SERVICES OF PENSACOLA, INC., and its mailing address is 313 South 61st Avenue, Pensacola, FL 32506.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgment of these Articles of Incorporation.
