

#### ARTICLES OF INCORPORATION

OF

#### BOOKEND Management, Inc.

#### ARTICLE I. CORPORATE NAME.

The name of this Corporation is: BOOKEND Management, Inc.

#### ARTICLE II. ADDRESS OF PRINCIPAL OFFICE.
