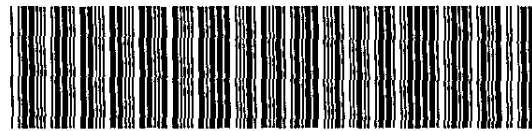



The under signed, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of this corporation shall be: Industry People OnLine, Inc..

ARTICLE II: DURATION OF BUSINESS

The term of existence shall begin March 7, 2006, and shall be perpetual.

ARTICLE III: NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation shall be and is to engage in every aspect as a placement service for people in the entertainment industry.

ARTICLE IV: CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be one thousand (1,000) shares of common stock. Such shares shall be single class, and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE V: ADDRESS


The seal of the corporation shall be circular with the name Industry People OnLine, Inc. around the border and "Florida Seal, 2006" in the center.

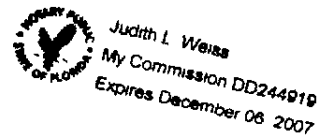


