ARTICLES OF INCORPORATION

OF

S & J 18TH TEE, INC.

ARTICLE I - NAME

The name of the corporation is S & J 18th Tee, Inc., at 1601 Adview Road SE, Palm Bay, FL 32909 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
