The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of the corporation shall be Nelson Muncil, Inc. And the corporation's principal address shall be 7605 Woodland Creek Lane, Lake Worth, FL 33467.

ARTICLE II TERMS OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III NATURE OF BUSINESS AND POWERS
