



## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION FOR JAMES PATRICK MCCUNE INVESTMENTS, INC.

## Change of Name:

THIRD: Article I of the Articles of Incorporation is amended to provide as follows, to wit: The general nature and purpose of the corporation are:

- a. To engage in the practice of law in the State of Florida pursuant to rules and regulations of the Florida Bar and the provisions of Chapter 621, Florida Statutes; and
- b. To do everything necessary, proper, or convenient for the accomplishment of the foregoing purposes, and to do every other act incidental to the corporate purposes which are not prohibited by the laws of the State of Florida.
- c. The purposes of this corporation shall be carried out only through officers, employees and agents holding such licenses as may be required by the laws of the State of Florida to lawfully conduct the business of the corporation.

FOURTH: The foregoing amendments were adopted by the Board of Directors on the 16<sup>th</sup> day of May, 2006.

FIFTH: The amendments were adopted unanimously by the shareholders of the corporation on the 16<sup>th</sup> day of May, 2006.
