ARTICLE I. NAME

NAME: The name of this corporation is R & S FILL, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 10th day of March, 2006.

ARTICLE III. NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common stock.


ARTICLE V. PREEMPTIVE RIGHTS


ARTICLE X. INDEMNIFICATION
