ARTICLES OF INCORPORATION OF INSPIRE REHABILITATION SERVICES, INC

THE UNDERSIGNED, natural person(s) of legal age, acting as incorporator(s) for the purpose of forming a corporation under the laws of the State Florida adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME


