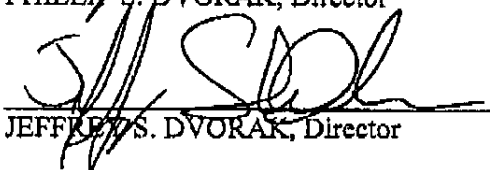
FOURTH: This amendment was adopted on March 14, 2011 by the Board of Directors.
