## ARTICLES OF INCORPORATION OF

#### FIRST LIGHT COUNSELING MINISTRY, INC.

The undersigned, for the purpose of forming a corporation for profit under  $\mathbb{B}$  Florid General Corporation Act, hereby adopts the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation is: FIRST LIGHT COUNSELING MINISTRY, INC

#### **ARTICLE II - DURATION**

The term of existence of the corporation is perpetual.

#### ARTICLE III - PURPOSE
