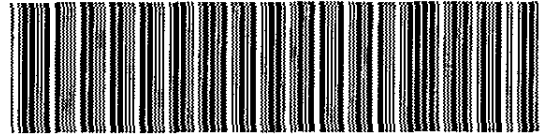

NEW CORPORATE NAME

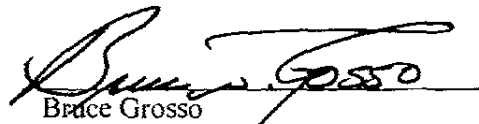
The corporation shall be known as
