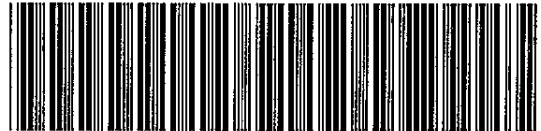

**NAME OF CORPORATION**
