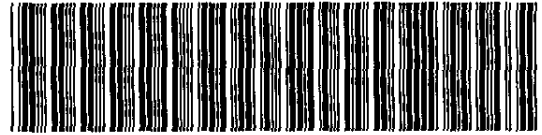

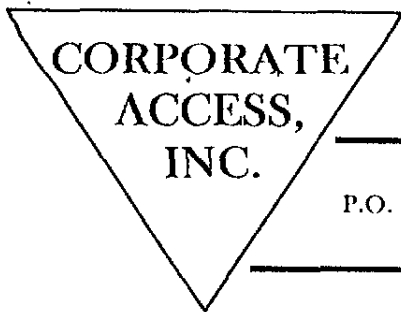

ARTICLE I - NAME

The name of this corporation is CAY EXPORTS, INC., 5 Seneca Road, Sea Ranch Lakes, Florida 33308.

ARTICLE II - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III - EFFECTIVE DATE

The date of commencement of corporation existence shall be March 14, 2006.

ARTICLE IV - NATURE OF BUSINESS

This corporation shall have the power to do any act in business or commerce as is now or hereafter may be authorized under the provisions of Chapter 607, Florida Statutes 2006.

ARTICLE V - CAPITAL STOCK

ARTICLE VIII - BYLAWS

The Directors of this Corporation shall adopt Bylaws which shall contain provisions for the management of the business and the regulation of the affairs of the Corporation that are not inconsistent with the Articles or the laws of the State of Florida.
