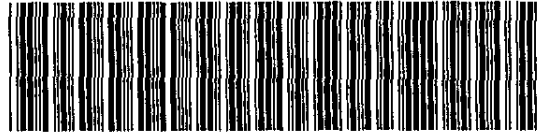

ARTICLE I - NAME

The name of this corporation is RJS Appraisal Company, Inc.

ARTICLE II - DURATION

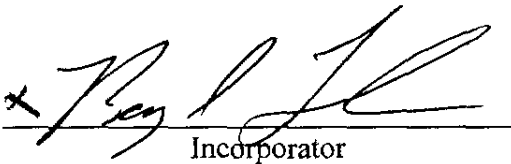

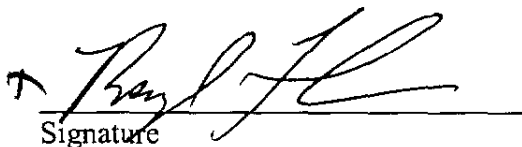

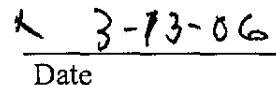
