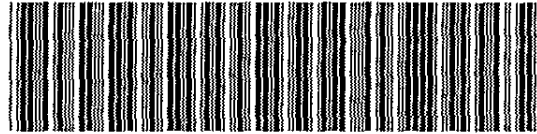

SECOND: The Company's articles of incorporation were filed on March 15, 2006.


THIRD: The Corporation has not commenced business and none of the Corporation's shares of stock have been issued.
