ARTICLES OF INCORPORATION OF CORDERO & ASSOCIATES, P.A.

The undersigned does hereby subscribe to, acknowledges and files the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is CORDERO & ASSOCIATES, P.A.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida including but not limited to Legal Services.
