On May 2, 2007, Jane Tierney, the Secretary of Mitchell O'Neil, A.I.A., P.A., phoned the Division of Corporations. When she reached a representative (Michelle Milligan), Jane explained that we had been trying to download the annual report form or to file on line since April 30th. From April 30th through mid-day May 2nd, we had received error messages saying the system was unavailable or our request timed-out. We tried at least 100 times in the three-day period. We had tried to phone for help but received constant busy signals.
