## ARTICLES OF INCORPORATION

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

## ARTICLE I - NAME

The name of the corporation is The Aslan Group Financial Services, Inc.

## ARTICLE II - TERM

The duration of the corporation is perpetual. The date and time of the commencement of the existence is when the Articles are received in the commencement. corporate existence is when the Articles are received in the office of the Secretary of State.

#### ARTICLE III - PURPOSE

The general purposes for which the corporation is organized are:

- 1. To operate as a Mortgage Brokerage Business. To act as a broker, or lender, in the making of mortgage loans. To acquire by purchase, or otherwise, and to own, hold, sell, Real Estate in the State of Florida and the United States at large. To manufacture, purchase, or otherwise acquire, and to own and mortgage, pledge, sell, assign and transfer or otherwise dispose of, and to invent, trade, deal in and with goods, wares, merchandise and other personal and real property of every class and description whatsoever,
- 2. To buy, sell, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purposes of any of the said.

- To act as a financial, business and purchasing agent for domestic and foreign corporations, individuals, partnerships, associations, state governments and other bodies.
- 4. To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges or franchises, or for any other lawful purpose of its incorporation, to issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidences of indebtedness payable at a specific time or times, or payable upon the happening of a specified event or events, secured or unsecured, from time to time, for moneys borrowed or in payment for property acquired, or for any of the objectives of the business of the corporation; secure the same by mortgage or mortgages, or deed or deeds of trust; or piedge or other lien upon any or all the property acquired or to be acquired; and to confer upon the holders of any debentures, bonds or other evidences of indebtedness or the corporation, secured or unsecured, the right to convert the principal thereof into any preferred or common stock of the corporation, as now or hereafter authorized upon such terms and conditions as shall be fixed by the Board of Directors; to sell, pledge, or otherwise dispose of any or all debentures or other bonds, noted and other obligation in such manner and upon such terms as the Board of Directors may deem judicious. To acquire by purchase, subscription or otherwise, and to own, hold, sell, vote and handle shares of stock in other corporations.
- 5. To have one or more officers conduct its business and promote the objectives within

and without the State of Florida, in other states, the District of Columbia, the territories, possessions and dependencies of the United States, and in foreign countries, without restrictions as to place or amount.

- 6. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attainment of any of the objectives, or the furtherance of any of the purposes or incidental to the protection and benefit of the corporation, as its principal agent, director, trustee or otherwise; and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful business necessary or incidental to the accomplishment of the purposes or the attainment of the objectives, or the furtherance of the purposes or the attainment of the objectives, or the furtherance of such purposes or objectives of the corporation, whether or not such business is similar in nature to the purposes and objectives as set forth in this Certificate of Incorporation or any amendment hereof.
