OF

ARTICLE I - NAME

The name of this Corporation shall be SARA S. LEVINE, M.D., P.A., a Florida professional association ("Corporation").

ARTICLE II - DURATION

This Corporation shall commence existence immediately upon filing these Articles of Incorporation and shall exist perpetually thereafter unless dissolved according to law.

ARTICLE III - PURPOSE & POWERS

Except as restricted by these Articles of Incorporation, this Corporation is organized for pediatrics, internal medicine and each and every legal and lawful purpose for which a Corporation may be organized under Chapter 621 of Florida Statutes.
