ARTICLES OF INCORPORATION

OF

TALLAHASSEE, FLORIDA

CLAUDIA SERNA P.A.

In compliance with Chapter 607 and/or Chapter 621,F.S. (Profit) Professional Corporation

ARTICLE I NAME

The name of the corporation is Claudia Sema P.A. (the "Corporation").

ARTICLE II PRINCIPAL OFFICE

The Address of the principal office and the mailing address of the Corporation is:

ARTICLE III SPECIFIC PURPOSE

This corporation may engage in or transact any lawful activities or business permitted under the laws of the United States of Florida, or any other state, country, territory or nation. This Corporation will act as a Professional Real Estate Services Corporation.

ARTICLE IV SHARES

The aggregate number of shares of all classes of capital stock that this Corporation shall have authority to issue is one thousand (1,000), consisting of one thousand (1,000) shares of common stock, par value 0.001 per share (the "Common Stock").

The designations and the preferences, limitations and relative rights of the Common Stock of the Corporation are as follows:

Provisions relating to the Common Stock.

Voting Rights.

a) Except as otherwise required by law or as may be provided by the Resolutions of the Board of Directors, all rights to vote and all voting power shall be vested exclusively in the holders of the Common Stock

b) The holders of the Common Stock shall be entitled to one vote per share on all matters submitted to a vote of shareholders, including, without limitation, the election of directors.

Dividends.

Except as otherwise provided by law as may be provided by the resolutions of the Board of Directors, the holders of the Common Stock shall be entitled to receive when, as and if provided by the Board of Directors, out of funds legally available therefore, dividends payable in cash, stock or otherwise.

Liquidating Distributions. Upon any liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary, and after payment or provisions for payment of the debts and other liabilities of the Corporation, the remaining assets of the Corporation shall be distributed pro-rate to the holders of the Common Stock.

ARTICLE V INITIAL OFFICERS/DIRECTORS

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws. The number of Directors constituting the initial Board of Directors is one and the names of the members of the initial Board of Directors, who are to serve as the Corporation's directors until successors are duly elected and qualified:
