THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, DO HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

# ARTICLE ONE:

THE NAME OF THE CORPORATION: Lucy's Child Care, Inc.,

THE DURATION OF THE CORPORATION IS PERPETUAL
