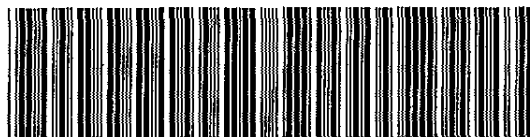

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: **SHARED ASSETS, INC.**

ARTICLE II. ADDRESS

The street address of the principal office for the corporation in the State of Florida is **9644 Moon Lake Road, New Port Richey, FL. 34654**. The board of directors may from time to time move the principal office to any other address in the State of Florida and may establish a branch office in such other place as may be designated by the board of directors.

ARTICLE III. CAPITAL STOCK

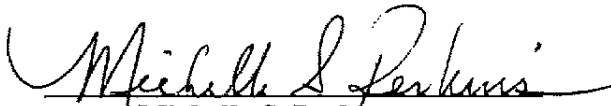
ARTICLE IX. AMENDMENTS

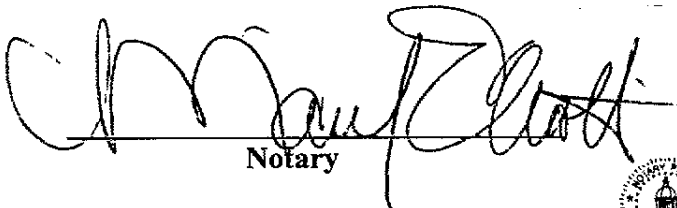

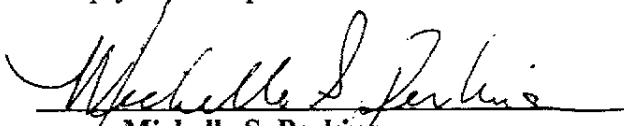
