**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I. NAME

The name of the corporation is Build To Suit Contractors, Inc.


ACCEPTANCE OF DESIGNATION
