ARTICLES OF INCORPORATION

FOR

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME. The name of the corporation shall be STUDENT RESEARCH, INC.

ARTICLE II

<u>PLACE OF BUSINESS.</u> The principal place of business and the mailing address of this corporation shall be:

ARTICLE III

STOCK. The number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand (1,000) shares.
