TALLAHASSEE FLORIDA

The undersigned, acting as the incorporators, adopt these Articles of Incorporation and form a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I. <u>Name</u>

The name of the Corporation is CINCO Insurance Company.

II. Term of Existence

The date when corporate existence will commence is March 17, 2006 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

III. <u>Kinds of Insurance</u>

The Corporation is organized to provide Medicare fee-for-service insurance.

IV. Principal Office

The principal office and mailing address of the Corporation is 5420 Bay Center Drive, Suite 250, Tampa, in Hillsborough County, Florida 33609.

V. Capital Stock
