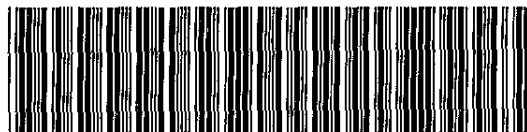

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Ray's All About Plastering, Inc., and its principal place of business shall be located at 2833 S. Oakland Forrest Drive, Apt. 104, Oakland Park, FL 33309.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of common stock at one dollar (\$1.00) par value, which shall be designated as "Common Shares."

ARTICLE VII - DIRECTORS

Initially, this corporation shall have three (3) Directors who shall serve until their successors shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors.
