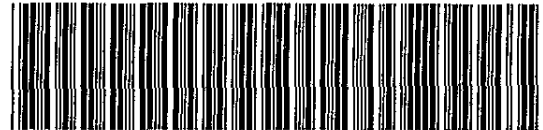




#### OTHER PROVISIONS:


