

ARTICLE ONE - NAME & ADDRESS

The name of the Corporation is **MOVIES IN MINUTES INC**, and the principle place of business of the corporation shall be: 187 BANYAN BAY DR, ST PETERSBURG, FL 33705-4770.

ARTICLE TWO - NATURE OF BUSINESS

This corporation may engage in any activity or business that is permitted under the laws of the United States and of the State of Florida. 
